

# Foveate Privacy Policy

At Foveate, a Third Axis, LLC company, we are committed to protecting and respecting your privacy. This privacy policy sets out the basis on which we will process any personal data that we collect from you, or that you provide to us. It applies to information we collect about visitors to our websites and people who use or enquire about our services. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it. By using our websites and our services you are accepting and consenting to the practices described in this privacy policy.

## **Use of Your Information**

This privacy policy tells you how and why we collect your personal data.

This privacy policy applies to information we collect about:

- visitors to our websites;
- people who use our services; and
- people who subscribe to our newsletter.

If you are paying for any services online we will collect an initial payment using card information through Stripe. Subsequent monthly payments will be billed via invoice and subject to 30 day payment terms.

When you visit our websites we collect standard internet log information such as Internet Protocol (IP) address, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform. We also collect information about your online activity in order to measure the number of visitors to our website, and to improve our website. This may include details such as your URL, visits to, through and from our website (including date and time), length of visits to certain pages, page interaction information (such as scrolling, clicks and mouse-overs) and methods to browse away from the page.

We do not share this information with any third parties except those directly involved in collecting and processing it (such as Google Analytics). However, we do reserve the right to use any data you provide to us when using our website or the services on our other websites, for apps provided by third parties or in relation to other services that we believe you may be interested in.

We will also collect information that can identify you, such as your name, office address, office telephone number, e-mail address, and other similar information when you provide it to us via contact forms, newsletter subscription forms, downloads and/or online tools.

We use the information we collect to:

- administer and provide our products and services;
- notify you about changes to our services;
- ensure that content from our website is presented in the most effective manner for you and for your computer;
- provide you with information about products and services that you request from us, or about other goods and services we offer that are similar to those that you have already purchased or enquired about;
- carry out our obligations under any contracts entered into with you;
- enable internal operations including troubleshooting, data analysis, testing, research, statistical and survey purposes;
- allow you to participate in interactive features of our services;
- measure or understand the effectiveness of advertising or promotions we send to you and others; and
- deliver relevant advertising or promotions to you.

### **Third-Party Access to Your Information**

We use the following third-party providers to deliver parts of the services we provide to you:

Brevo, to deliver our e-newsletter. We gather statistics around email opening and clicks using industry-standard technologies including clear gifs to help us monitor and improve our e-newsletter.

We host our website and your information using servers which are located in the USA and EU. Currently, we use Digital Ocean and Google Cloud Platform for hosting and services on servers located in the USA and EU.

Other companies from within our group who provide other services, our business partners, affiliates, sub-contractors, payment and delivery services providers, advertising networks, analytics providers, search information providers and credit reference agencies may have access to, and provide us with, information about you for the purposes of providing services to you generally.

We will only share your information with such persons to enable such third parties to provide services to you on our behalf.

## Use of Cookies

A cookie is a data file stored on a computer hard drive, mobile phone or other device which contains information about the user of our websites. We use cookies on our websites for the following purposes:

- identifying users so that they can access their data (for example, once you log in a cookie will be used to identify you);
- collecting analytics about how visitors use our websites (often via a third party such as Google Analytics) Such data includes how many times a visitor uses our websites, the site they came from and their physical location;
- storing preferences to remember a user's choice about how the websites should behave (for example which language they prefer). This cookie is, by default, set on arrival to our website;
- notification for our online registration form used for you subscribing to our newsletter. This cookie is set only for individuals who complete the form.

- recording prior actions to prevent us from asking individuals to complete an action who have either already completed it, or indicated they do not wish to do so (for example a response to a poll);
- banners to control the appearance of the cookies information banner. This cookie is set on arrival to our website by default. It expires after a set time and is not set again unless a user changes their cookie settings.

Third party services (such as YouTube) that are embedded in our websites may set cookies for similar purposes.

You can decide whether or not to accept the use of cookies on our websites by enabling or disabling cookies in your browser settings. You can find details of how to do this in your browser's Help pages. Please be aware that if you disable cookies for our websites critical features may not function.

### **Links to Other Websites**

This privacy policy does not cover use of other websites linked from our websites. We encourage you to read the privacy statements on other websites you visit. Our websites may contain hyperlinks to other third party websites not operated by us. You should read the privacy statements on such third party websites before providing any information about yourself.

### **Storage and Security of Your Information**

Information that we collect about you will be transferred to, and stored at, a destination outside the European Economic Area ("EEA"). It may also be processed by staff operating outside the EEA who work for us or for one of our suppliers or partners. Such staff maybe engaged in, among other things, the fulfilment of the service, the processing of your payment details and the provision of support services. By submitting your data, you agree to this transfer, storing or processing.

We will take all steps reasonably necessary to ensure that your information is treated securely and in accordance with this privacy policy. Where we have given you (or where you have chosen) a password which enables you to access certain parts of our website or services, you are responsible for keeping this password confidential.

Unfortunately, the transmission of information via the Internet is not completely secure. Although we will do our best to protect your information, we cannot guarantee the security of your information transmitted to our websites. Any transmission is at your own risk. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorised access.
